Other Relevant Information

a. On 6 August 2014, the 176,000,000 common shares of the Company in the name of Sunchamp Real Estate Development Corp have been assigned to 3 assignees. However, the respective certificates authorizing registration ("CAR") of these common shares have not yet been issued by the Bureau of Internal Revenue. After the approval by the Securities and Exchange Commission ("SEC") of the change in par value of the Company's common shares from P0.01 to P1.00, and the issuance of CAR on the assigned shares, Antonio L. Tiu owns (i) 10,000 common shares (direct), and (ii) 297,500,000 common shares (indirect), or a total of P297,510,000 common shares equivalent to 16.52% of the total issued and outstanding common shares of the Company.

b. The Company is still in the process of implementing the change in par value of its common shares as approved by the SEC. For purposes of this report, the common shares reflected in the following items: (i) Number of Listed Common Shares, (ii) Stock Purchase Plan, (iii) Total Number of Non-Public Shares, and (iv) Total Number of Shares Owned by the Public were rounded off. However, the same are still subject to change/adjustment upon completion of the implementation of the change in par value of common shares of the Company.
